Subject: - Conduct of July 2020, examination for terminal semester students

1. The university end semester examination for final (terminal) semester students of all courses will start from 2nd July, 2020.
2. The examination will be held in traditional / offline mode.
3. All the directions of Punjab Govt. about COVID-19 like wearing mask & social distance will be followed during examination. In this regard no. of exam centres will increased. Only 16 students will be allowed in a room of capacity of 60 students. All colleges having 20 such rooms can be established as examination centres. The colleges must inform the university regarding the sitting capacity of students by 10th June, 2020.
4. The process of filling examinations forms will start from 08/06/2020 & it will be notified separately in detail.
5. The duration of examination will be of 02:30 hrs. The date sheet will be released soon.
6. It is better that if the college can call the students who are from outside Punjab well in time around 20th June and make arrangements for quarantine of these students (if required) in consultation with district administration. It should be also kept in mind that monsoon season starts early in some states so it is better to call them early.
7. If the colleges feel that they cannot keep such students in isolated conditions then university can set up some examination centers outside Punjab especially in Bihar and J & K. The colleges are required to give their opinion in this regard upto 10th June.
8. The university campus can accommodate some students who will come from the far off places if colleges cannot provide them accommodation.
9. The students who are in Red zone or highly contaminated zone will not be allowed to take the examination. Their examination will be taken later on. The colleges are required to check the address of students carefully & identify such students.
10. The practical examination of these (terminal semester) students should be conducted immediately after theory examination (preferably within five days).
11. The colleges must instruct the student to check the notices daily on www.mrsstuexam.com.
12. The intimation regarding the conduct of examination for the remaining (lower) semesters will be given later on atleast 15 days before the start of examination.
