## **Subject: - Schedule for reappear examinations (Tentative)**

- 1. The reappear examinations of 2<sup>nd</sup>, 4<sup>th</sup>, 6<sup>th</sup> and 8<sup>th</sup> semesters will be held from 20th November 2020 for all courses and all eligible batches. As all the students have already filled their reappear examination forms so there is no need to fill reappear examination forms for this particular examination.
- 2. Candidates who have been promoted from even semesters to odd semesters and those who have given online examinations for final semester can avail this chance as special chance for improvement of their grades as per rules. Though no examination fee will be taken from such candidates, but they have to fill special examination form which will be notified separately.
- 3. The reappear examinations of odd semesters 3<sup>rd</sup>, 5<sup>th</sup> and 7<sup>th</sup> will start from 7<sup>th</sup> December along with regular examinations for these semesters. There is no need to fill examination form for reappear candidates as they have already done in June-July 2020 but the regular students have to fill examination forms and pay the requisite examination fee (the schedule of which will be notified separately).
- 4. All the above examinations will be held in **offline traditional mode** as has been done previously by establishing examination centers at various colleges and institutes hoping that COVID-19 situation will further improve by that time. The final decision regarding mode of examination will be notified 15 days before the examination depending upon COVID-19 situation at that time.
- 5. All the colleges/institutes are required to make suitable arrangements for the conduct of examinations as during examinations all the directions of Punjab Govt. regarding COVID-19 will be strictly followed.
